The following minutes were taken at the May, 2011 board meeting. Corrected and approved at June 8, 2011 meeting.

1. The regular board meeting was called to order by Supervisor Becker at 7:30 P.M. with the Pledge and a prayer. Board members present were JoAnn Becker, Rick Schoenborn, Linda Way, Tracy Worrell and Josh Westgate.
2. No additions to the agenda.
3. A motion was made by Westgate and supported by Schoenborn to approve the bills in the amount of \$23,883.95 and to accept the treasurer's report, Trust and Agency and Tax Account Profit & Loss. Motion carried. A motion was made by Schoenborn and supported by Westgate to approve the minutes of April 13, 2011 as written. Motion carried. *(attached)*
4. No public comments.
5. Commissioner Greg DeJong provided information on upcoming meetings. He will be attending a public hearing on reapportionment. *(attached)*
6. A motion was made by Way and supported by Schoenborn to approve the Rusche application for Soil Mining Permit renewal on Arthur Street pit. Motion carried. *(attached)*
A motion was made by Schoenborn and supported by Way to approve Rusche Soil Mining Permit renewal for 24th Avenue pit predicated on the Engineer's recommendation to submit a revised mining grading and reclamation plan to the township for review and approval. Motion carried. *(attached)*
7. Berlin Raceway Fireworks permit was tabled.
8. Snowplow bids were received from Evergreen, Legend and Wolf Creek. After discussion, a motion was made by Schoenborn and supported by Worrell to accept the bid provided by Legend Services. Motion carried. *(attached)*
9. A motion was made by Westgate and supported by Schoenborn to approve the reappointment of Roland DeVries for Library Board – term 7/1/11 – 7/1/15. Motion carried.
10. A motion was made by Way and supported by Schoenborn to approve the reappointment of Pat Raap to Zoning Board of Appeals – term 6/1/11 – 6/1/14. Motion carried.

11. A motion was made by Worrell and supported by Westgate to adopt Resolution 11-05-01 Sewer Customer Adjustments. Roll call vote. All ayes. Resolution declared adopted.

12. Westgate presented a detailed presentation on copiers with additional information on lease vs. owned from various companies. A motion was made by Schoenborn and supported by Becker to purchase the HP Model 9040 from Noordyk Business Equipment. Motion carried. Westgate will request a lower rate on purchase price and maintenance agreement.

13. Reports were given.

14. Supervisor Becker discussed that Creekview and Superior Steel Components are closing. The Marne Lion's were generous to purchase street flags to be displayed in Marne. Thank you very much. Also appreciation to Rodney Prys for purchasing the POW-MIA flag that will be displayed in the Veterans Memorial Park. Rodney will also hang the street flags in Marne.
