

**WRIGHT TOWNSHIP  
REGULAR BOARD MEETING  
FEBRUARY 10, 2010**

*The following minutes were taken at the February, 2010 board meeting and are currently unapproved.*

1. The regular board meeting was called to order by Supervisor Becker at 7:30 P.M. with the Pledge and a prayer. Board members present were JoAnn Becker, Tracy Worrell, Rick Schoenborn and Josh Westgate. A motion was made by Schoenborn and supported by Westgate to approve the absence of Clerk Way. Motion carried.
2. No additions to the agenda.
3. A motion was made by Schoenborn and supported by Westgate to approve the bills in the amount of \$40,281.64 and to accept the treasurer's report, Trust and Agency and Tax Account Profit & Loss. Motion carried. There will be a pre-budget workshop Thursday, February 18 at 2:00 P.M. There will also be a special meeting at 6:00 P.M. on March 10, 2010 to review the budget before the regular board meeting. A motion was made by Westgate and supported by Worrell to approve the minutes of the January 13, 2010 Regular Board as written. Motion carried.
4. Attorney David Rhem was in attendance to introduce himself to the board as he is running for Ottawa County Circuit Court Judge in the upcoming November general election.
5. Phil Keilman, from Great Lakes Chloride Inc., presented a bid for dust control. A bid was also received from Michigan Chloride Sales LLC. It was decided that more research and discussion was needed on the issue. A motion was made by Schoenborn and supported by Westgate to table a decision on which bid to accept until the March regular board meeting. Motion carried.
6. Dan VanDyke is willing to continue to serve on the Planning Commission in the S.E. Quadrant, Term: 04/01/10-04/01/13. Anyone else in the S.E. Quadrant interested in serving on the Planning Commission should contact Supervisor Becker by March 1.
7. Resolution 10-02-01: To establish Township Officers Salary. Due to the difficult economic times, no increases were considered for any office. A motion was made by Schoenborn and supported by Westgate to retain the current salary of \$19,500 for the office of Supervisor. Roll call vote- all ayes. Absent Way. Resolution declared adopted. A motion was made by Westgate and supported by Schoenborn to retain the current salary of \$19,000 for the office of Clerk. Roll call vote- all ayes. Absent Way. Resolution declared adopted. A motion was made by Schoenborn and supported by Westgate to retain the current salary of \$18,500 for the office of Treasurer. Roll call vote- all ayes. Absent Way. Resolution declared adopted.

8. Resolution 10-02-02 to Establish the Purchase Price for Grave Sites and other Related Costs and Conditions. A motion was made by Schoenborn and supported by Worrell to set the price for burial lots at \$400 for Wright Township residents and \$800 for non-residents, and to set as policy that any additional costs incurred because of a burial that takes place during the winter season shall be the responsibility of those who contract for these services. Roll call vote- all ayes. Absent Way. Resolution declared adopted.
