8 – Motion was made by Karr to accept, and file the resignation of Trustee Schoenborn. Frank second, and roll call was taken. Ayes: Karr, Dietrich, and Frank. Nays: None, Absent: None. Motion carried.

9 - Theresa Frank nominated Richard Schoenborn for Township of Wright Supervisor. Any more nominations asked three times, hearing none nominations were closed.
